Introduction

This report presents the developments in merchandise exports and imports of the Kingdom of Saudi Arabia for June 2018 as compared to the same period of the previous year, June 2017, according to the statistical methods and various classifications. The data for this report were collected from the Saudi Customs and the Ministry of Energy, Industry, and Mineral Resources.

All the data contained in this report and more details are attached to this report in an Excel file, which could be downloaded from the [website](#) of the General Authority of Statistics (GaStat).

It should be noted that the statistics presented in this report are preliminary and they June undergo some modifications in case of a data update.

Note: There might be some differences in the aggregates of numbers or percentages due to rounding.

Methodology

Description

This report presents the statistics on exports and imports of the Kingdom of Saudi Arabia for the latest month with available data in comparison with the same period from last year. It highlights the main developments with summary tables and charts. Given the importance of oil exports to the Saudi economy, total exports are separated into oil exports and non-oil exports. Non-oil exports and imports are then presented in various classifications such as by section (HS), by group of countries, by partner countries, by means of transport and customs port. Appendix tables are also given at the end of the report and in a separate Excel file that could be downloaded from the GaStat website.

Data Collection, Processing, and Dissemination

The General Authority for Statistics receives the monthly data from two sources; (i) Saudi Customs and (ii) Ministry of Energy, Industry, and Mineral Resources.

The data pass through several stages of treatment before dissemination, as explained below.

First Stage:

Entering the data on the system of foreign trade statistics to obtain a preliminary review of commodities, countries, and customs centers to ensure consistency and comprehensiveness of the data.

Second Stage:

The implementation of processing programs for detailed customs data, through the application of auditing rules and automatic correction to extract notes. These notes are either processed directly by expert statisticians in the Department of Foreign Trade Statistics or investigated from its official source. This stage continues until the monthly data is completely audited and corrected.

Third Stage:

Aggregation of monthly data by commodity and country automatically by means of programs dedicated to this purpose. After that, a final and comprehensive review is conducted and thus the data become ready to be published.

Fourth Stage:

Various tables for different classifications are extracted from the system to prepare the monthly report. The report is published on a regular basis every month on the GaStat website.

Classification Used

The basic data on the foreign trade included in this report is based on the Harmonized Commodity Description and Coding Systems, known as the Harmonized System (HS).





Concepts and Definitions

Exports (Total):

Exports consist of exports of domestic goods (national exports) and exports of foreign goods (re-exports). Valuation is on Free-on-Board (FOB) basis.

National Exports:

Exports of all goods fully produced or manufactured in the country or undergone some modifications that lead to a change in their shapes and values.

Re-exports:

Refers to the sale of previously imported goods abroad without any clear modifications on them.

Oil Exports:

Exports of goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS).

Non-oil Exports:

Total exports minus exports of goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS).

Imports:

Refer to all goods entering the country after passing through the customs procedures to meet its local needs. Valuation is on Cost, Insurance, and Freight (CIF) basis.

Trade Volume:

The sum of exports and imports.

Trade Balance:

Total exports minus imports.

Non-oil Trade Balance:

Non-oil exports minus imports.

Monthly change:

Change from the previous month.

Annual change:

Change from the same month of the previous year.

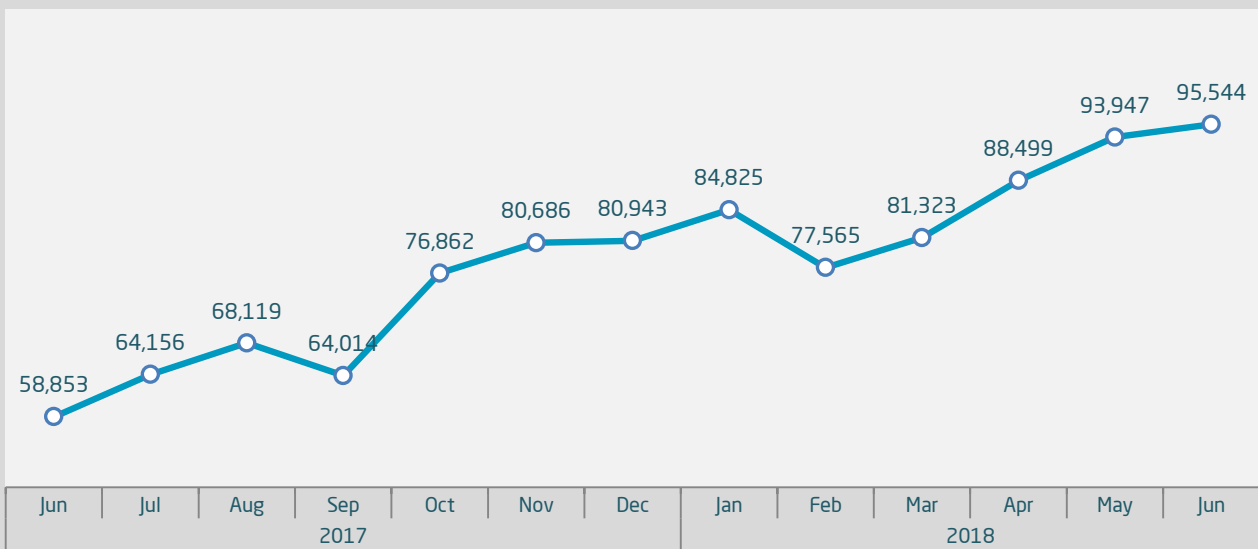




1. Merchandise Exports

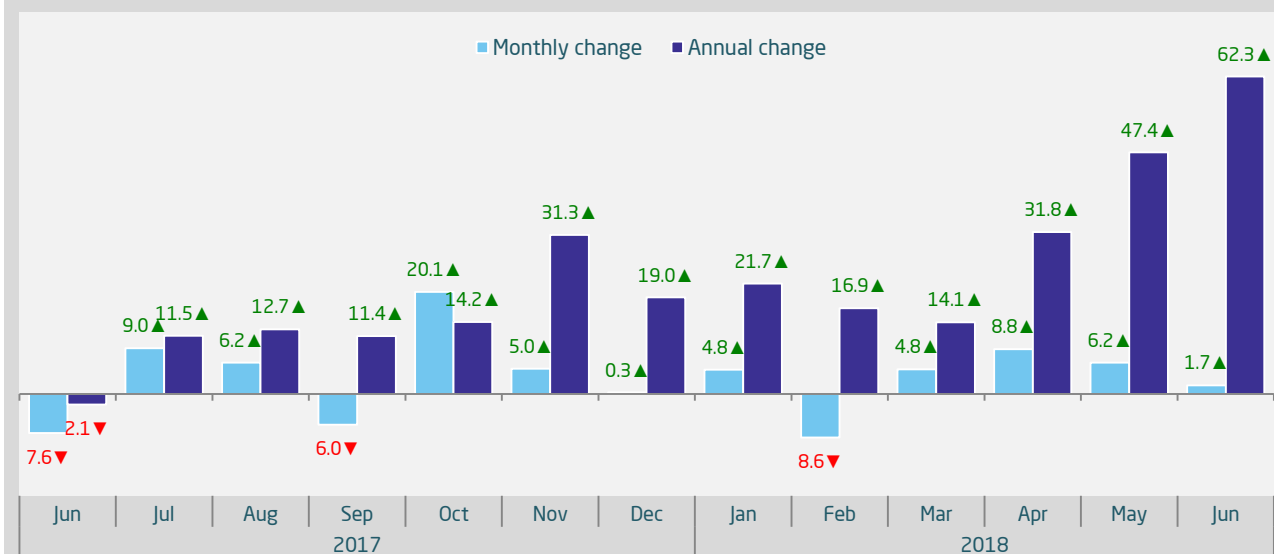
Merchandise exports of Saudi Arabia amounted to 95544 million riyals in June 2018 compared to 58853 million riyals in June 2017, with an increase of 36691 million riyals or 62.3%. Merchandise exports in June 2018 were also higher than those in the preceding month (May 2018) by 1596 million riyals or 1.7%.

Change in Exports (%)

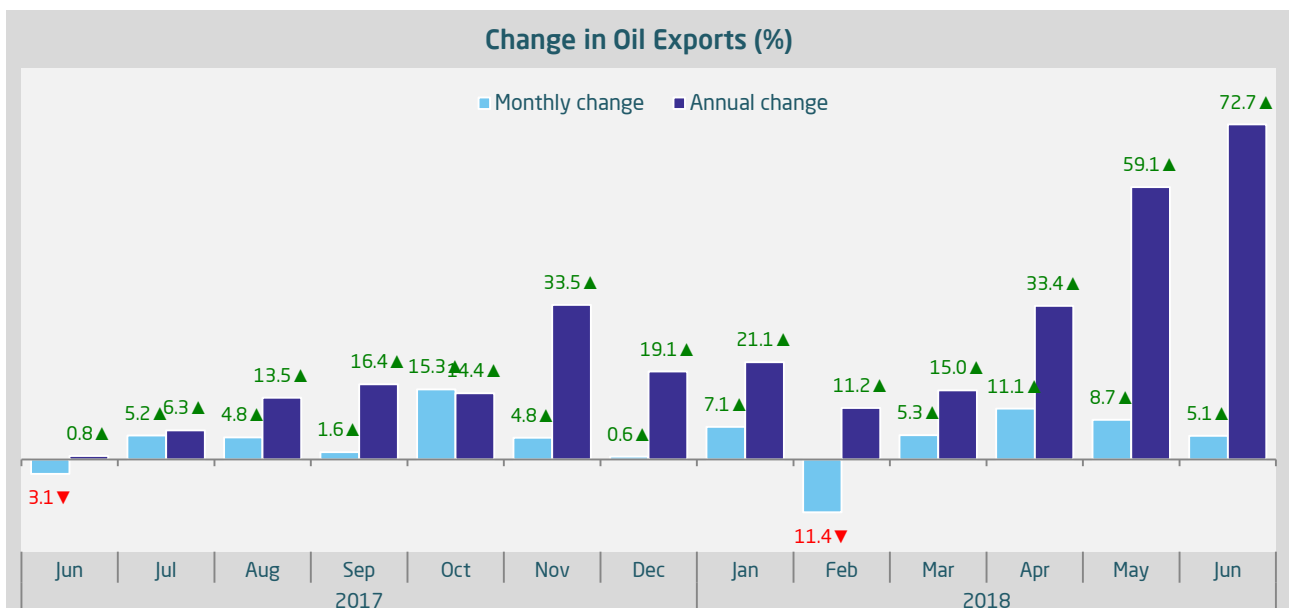
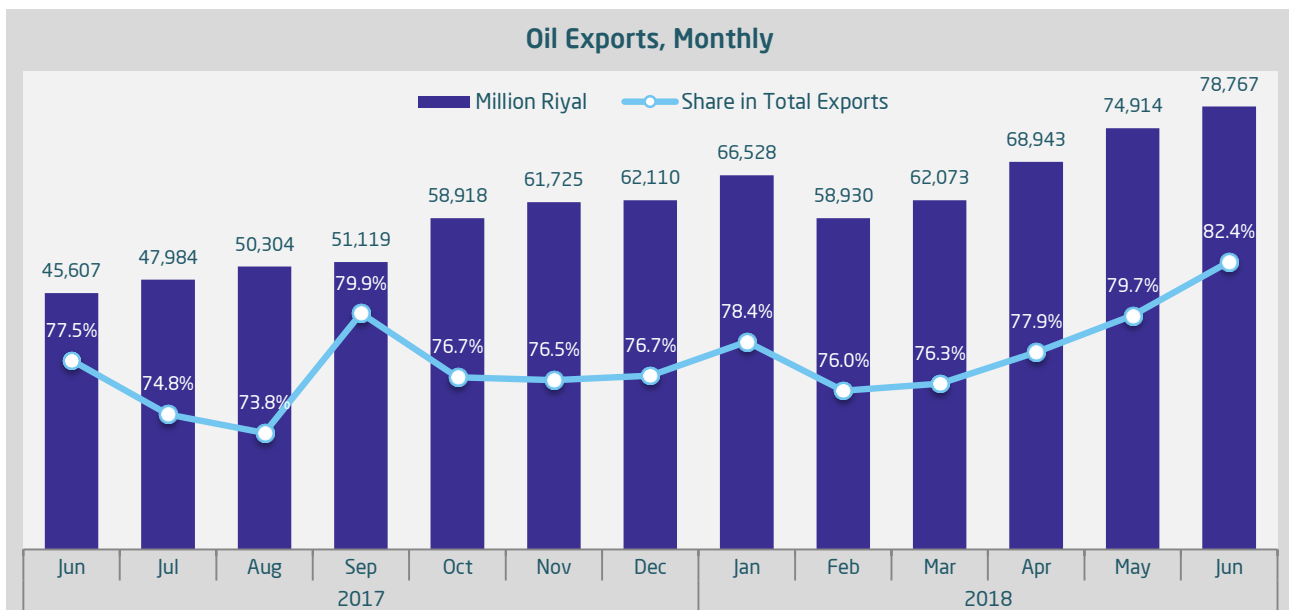




1.1. Oil Exports

Oil exports of Saudi Arabia amounted to 78767 million riyals in June 2018 compared to 45607 million riyals in June 2017, with an increase of 33160 million riyals or 72.7%. The share of oil exports in total merchandise exports also increased from 77.5% in June 2017 to 82.4% in June 2018.

Compared to the previous month (May 2018), the oil exports increased by 3852 million riyals or 5.1% in June 2018.



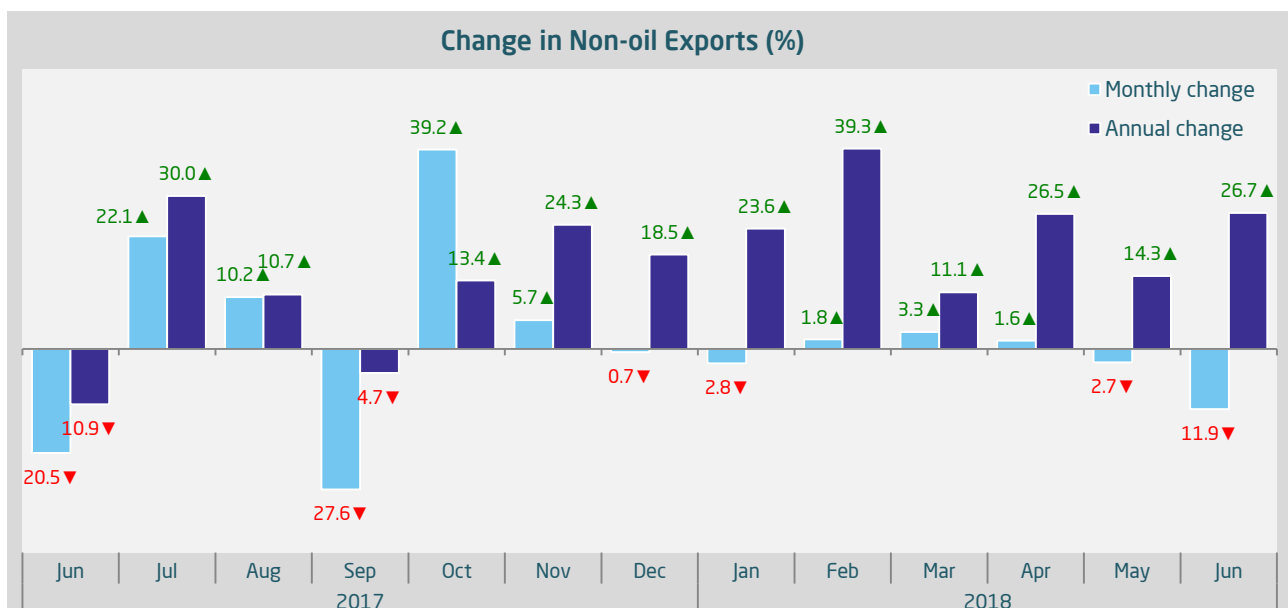
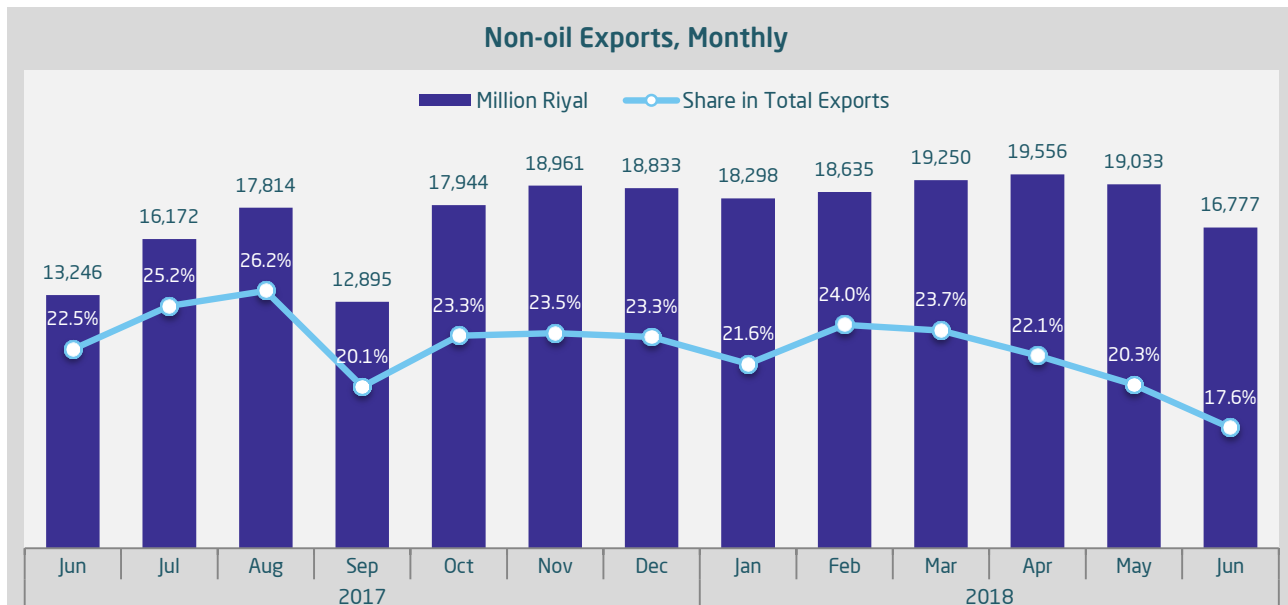


1.2. Non-oil Merchandise Exports

1.2.1. Developments in Non-oil Exports

Non-oil exports of Saudi Arabia amounted to 16777 million riyals in June 2018 compared to 13246 million riyals in June 2017, with an increase of 3531 million riyals or 26.7%. The share of non-oil exports in total merchandise exports, however, decreased from 22.5% in June 2017 to 17.6% in June 2018.

Compared to the previous month (May 2018), the non-oil exports decreased by 2256 million riyals or 11.9% in June 2018.

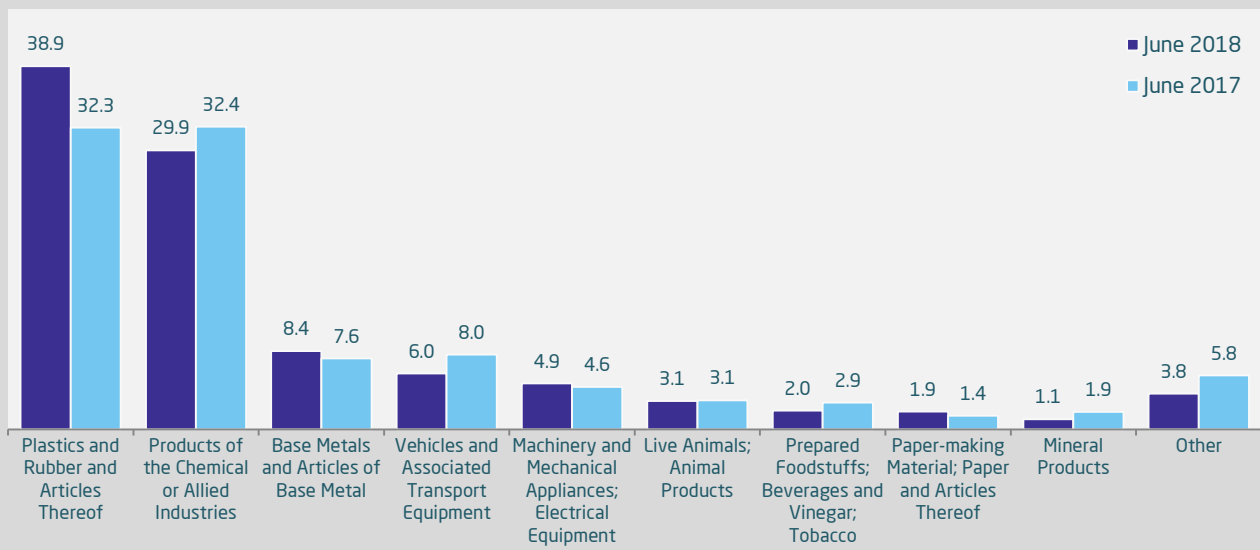




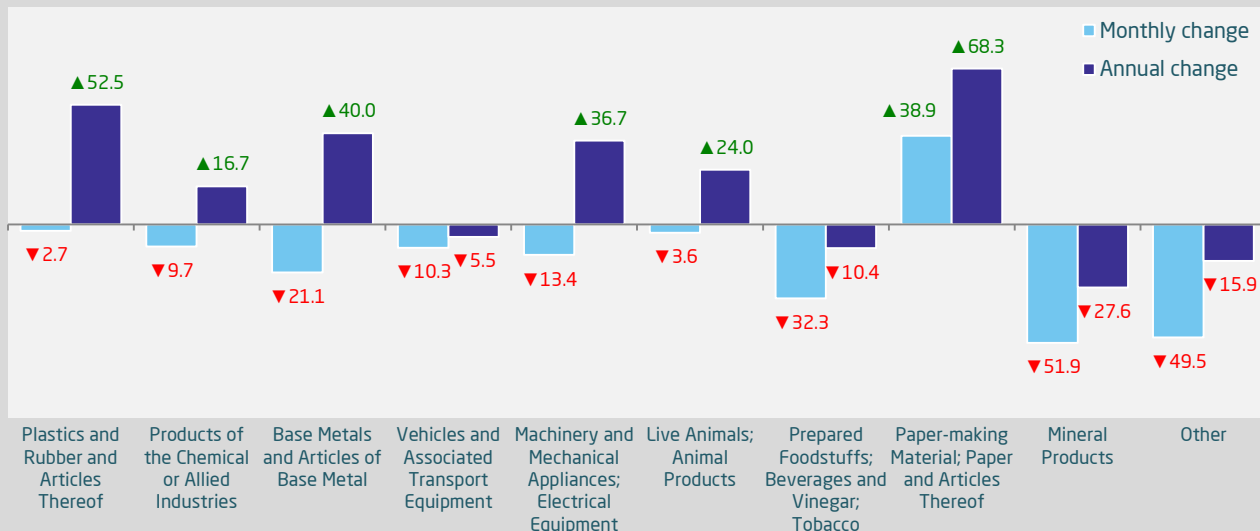

Main Non-oil Export Products in June 2018 (Share in total, %)



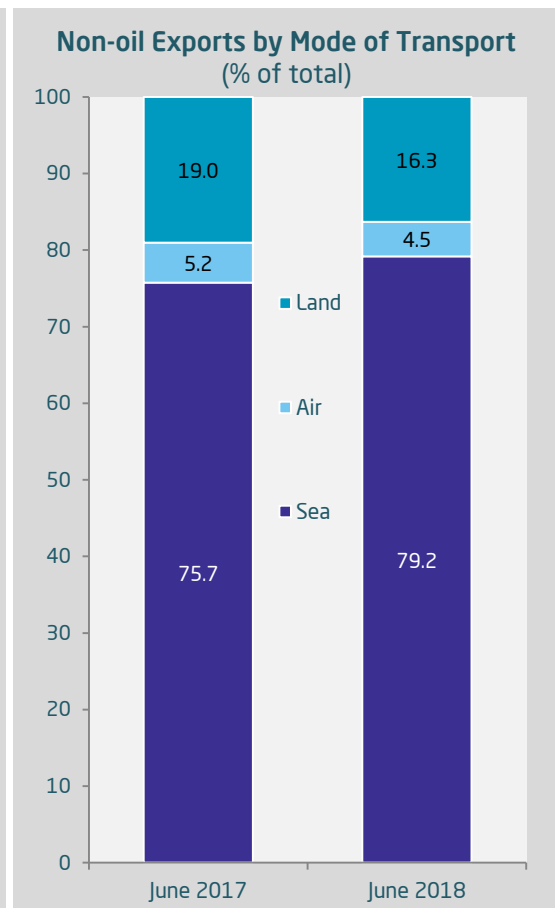
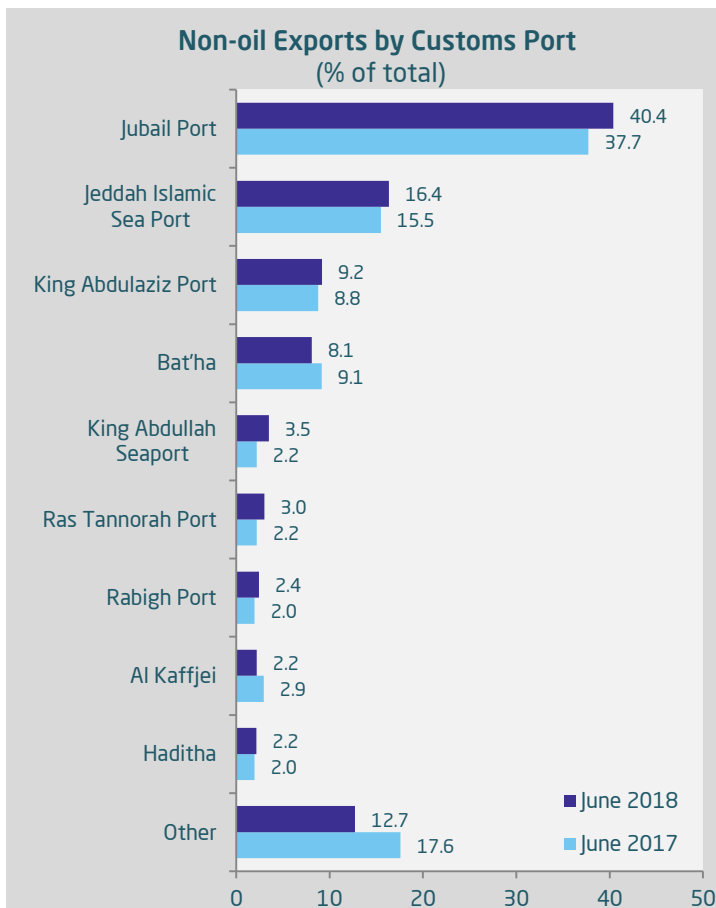
Change in Main Non-oil Export Products, June 2018 (%)

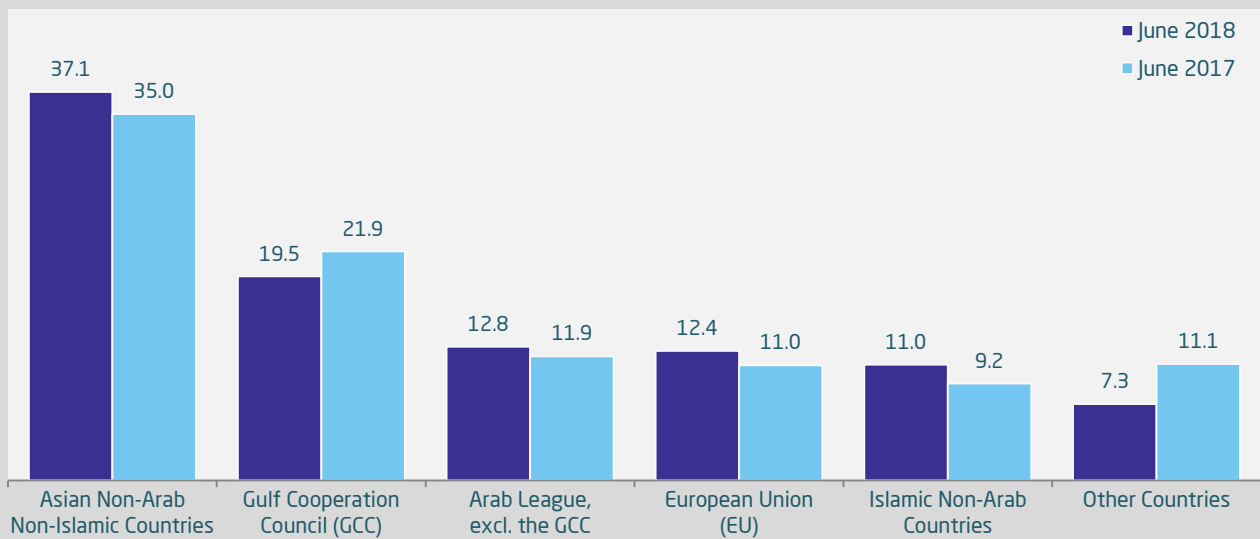




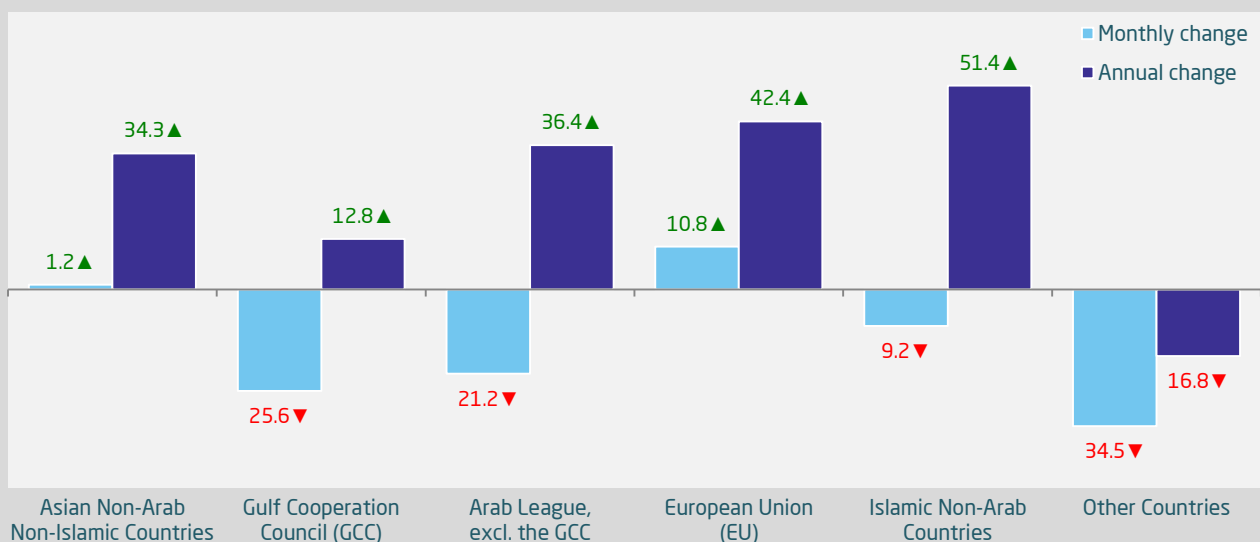

Change in Non-oil Exports by Group of Countries, June 2018 (%)

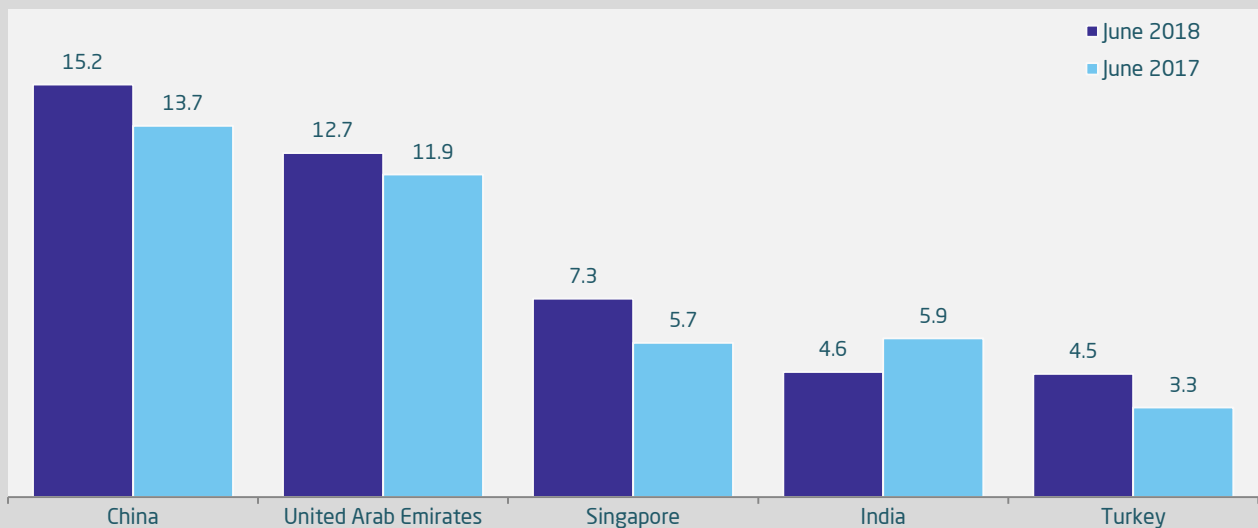




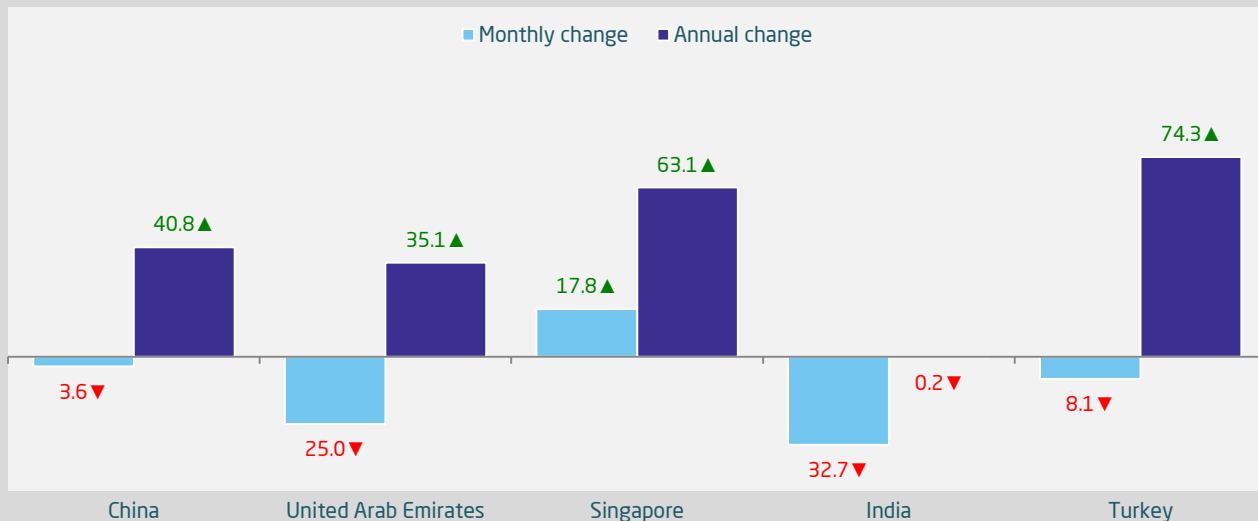

Change in Non-oil Exports to Top 5 Countries, June 2018 (%)

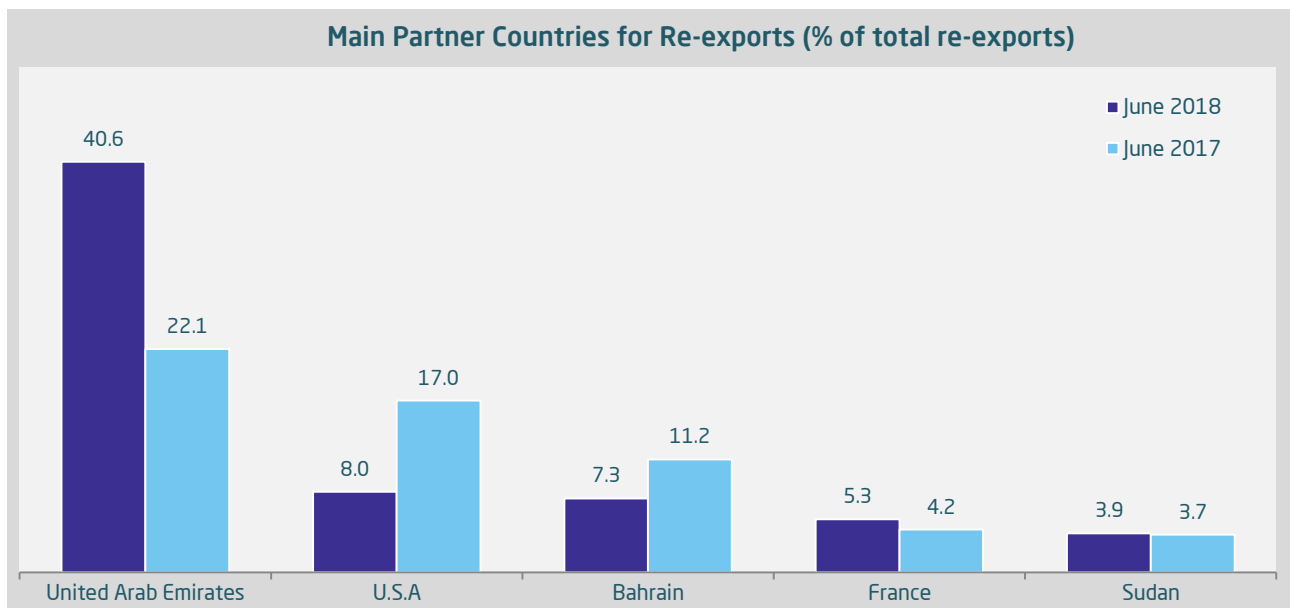
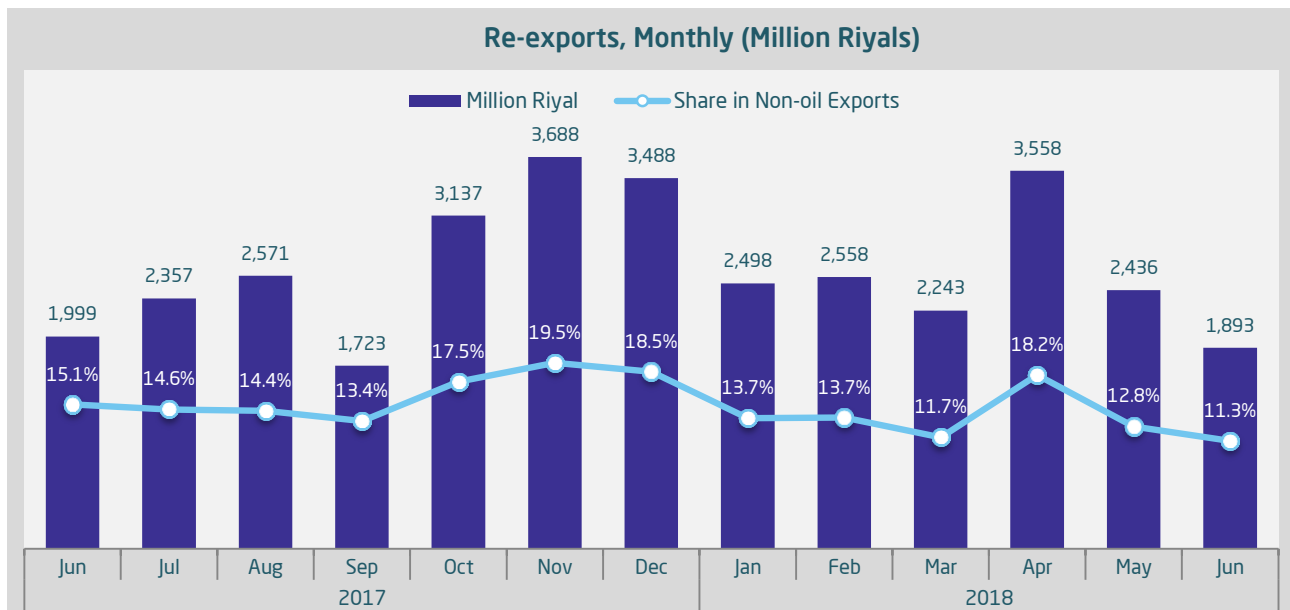




1.2.6. Re-exports

Products re-exported by Saudi Arabia amounted to 1893 million riyals in June 2018 compared to 1999 million riyals of the same month of the previous year, down by 107 million riyals or 5.3%.

United Arab Emirates was the main destination for the re-exports, accounting for 40.6% of the total re-exports of the Kingdom in June 2018, followed by U.S.A with a share of 8.0%.





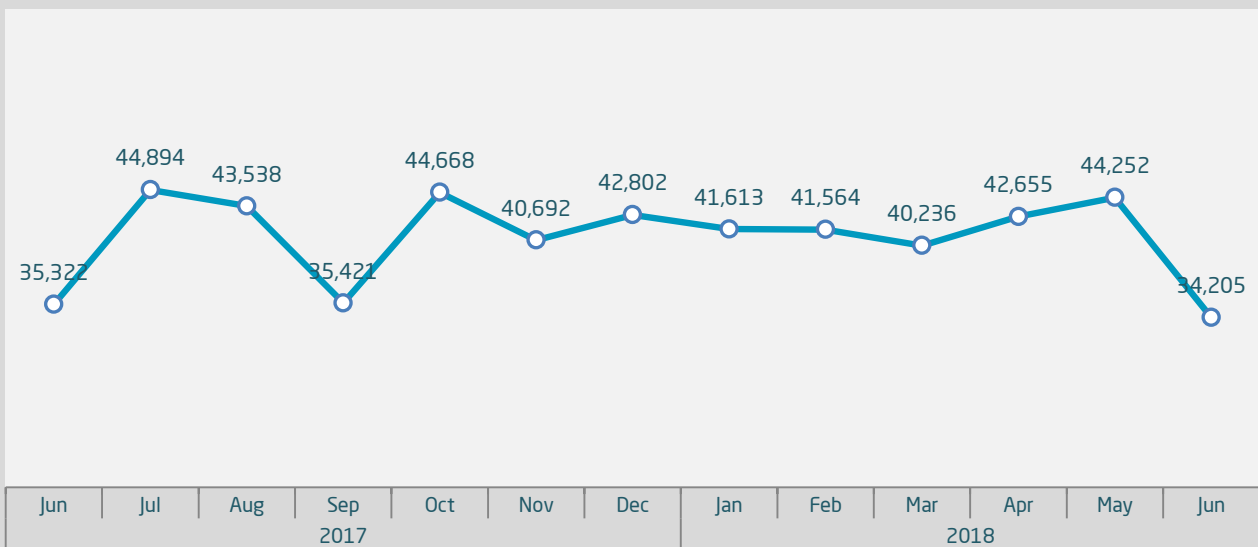
2. Merchandise Imports

2.1. Developments in Imports

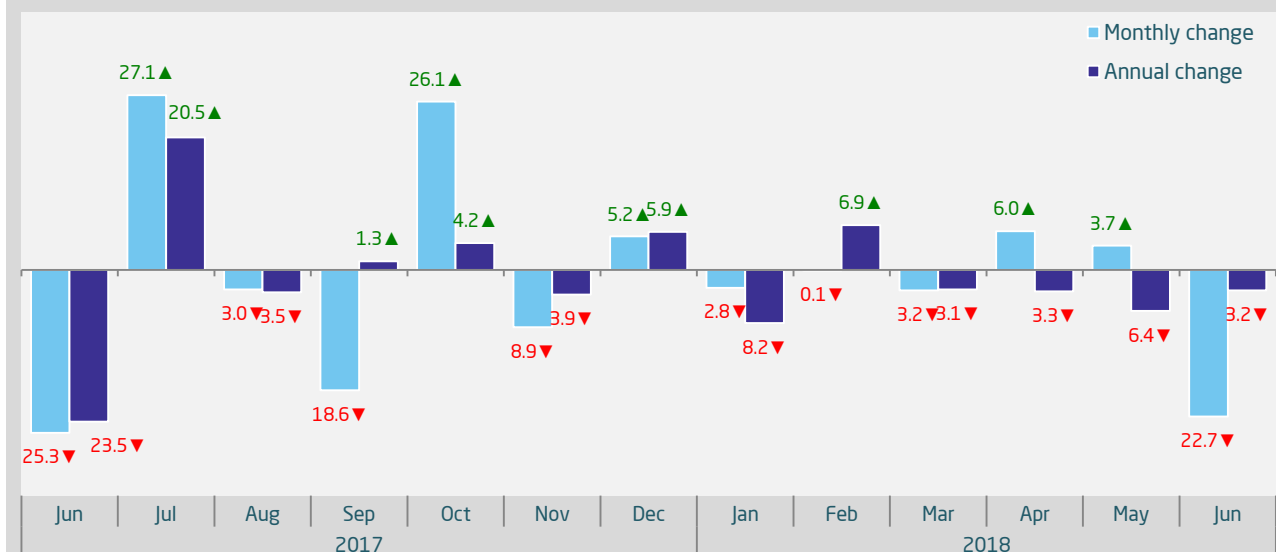
Total merchandise imports of Saudi Arabia amounted to 34205 million riyals in June 2018 compared to 35322 million riyals in the corresponding period of the previous year, down by 1118 million riyals or 3.2%.

Merchandise imports in June 2018 were also lower than those in the preceding month (May 2018) by 10047 million riyals or 22.7%.

Change in Imports (%)

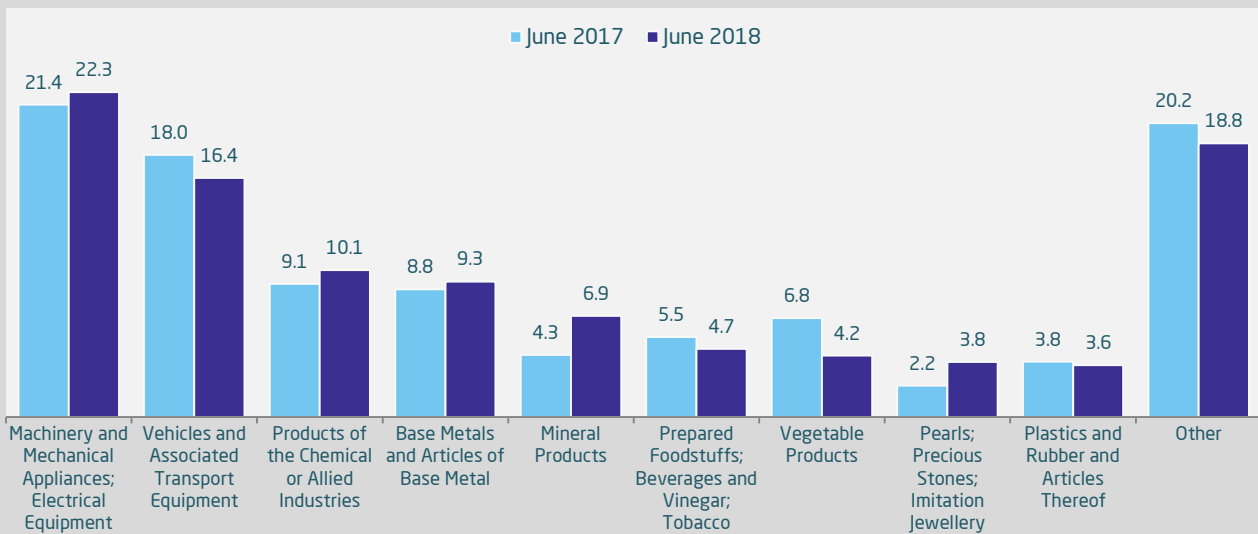




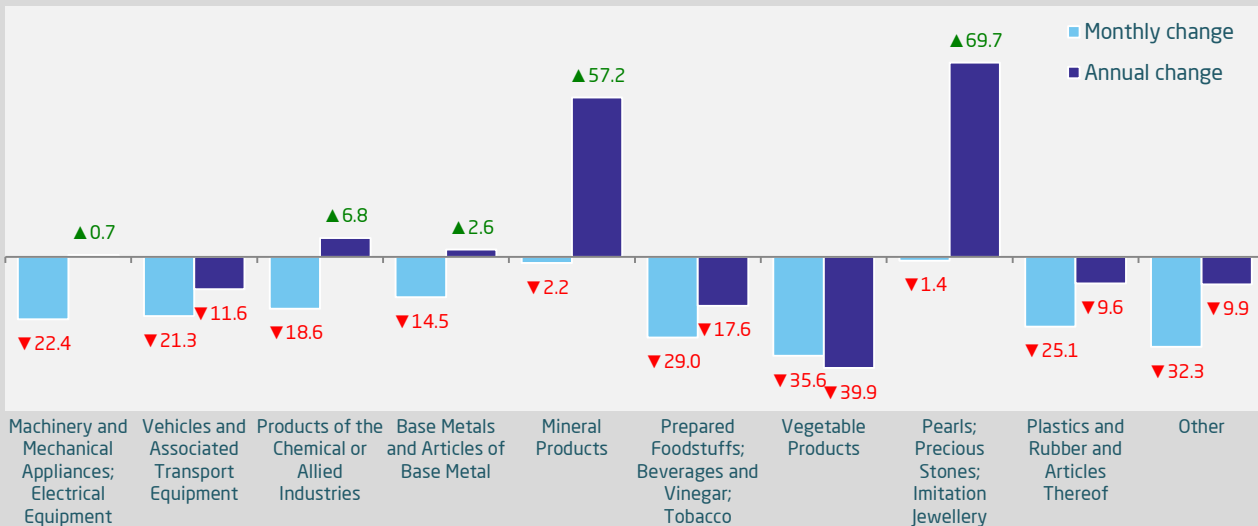

Main Import Products in June 2018 (Share in total, %)



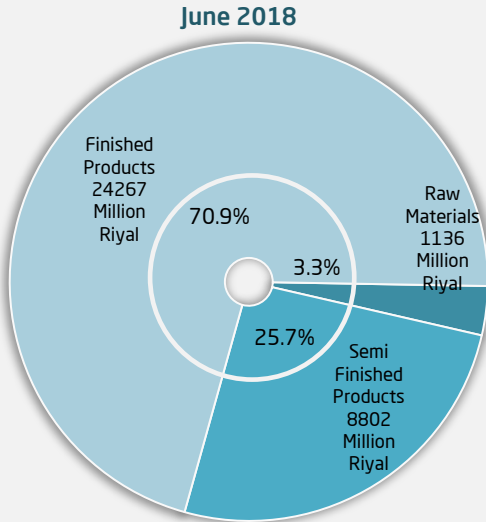
Change in Main Import Products, June 2018 (%)



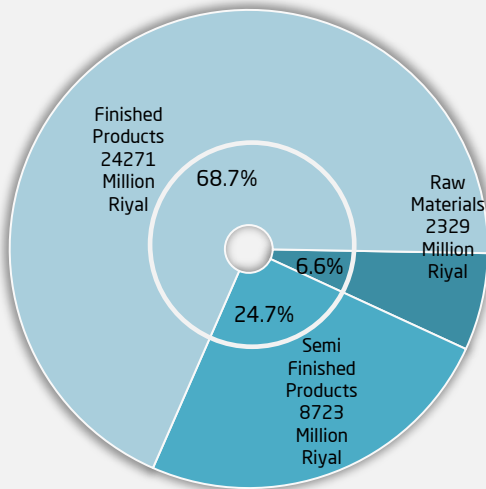

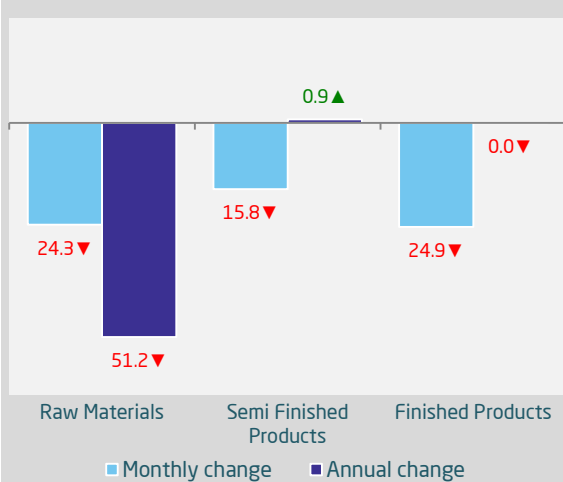
Imports by Nature of Items



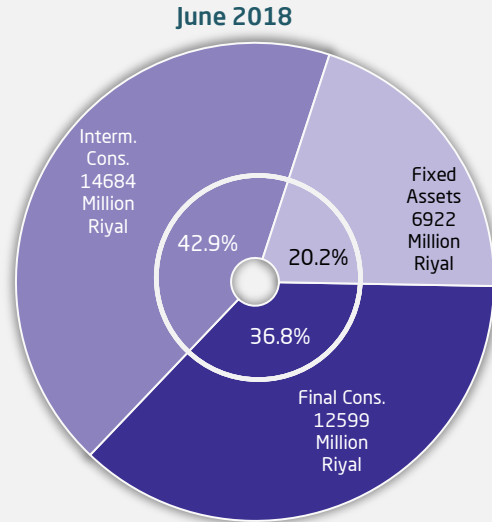

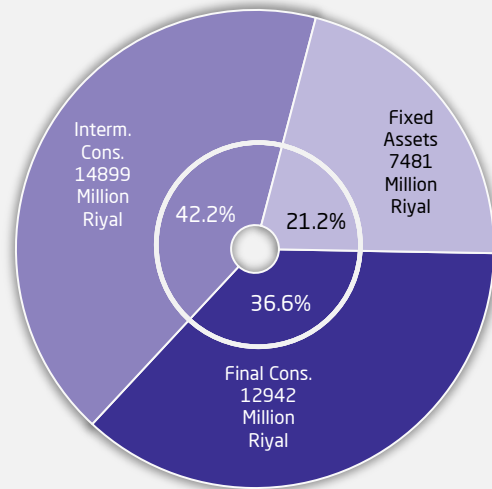

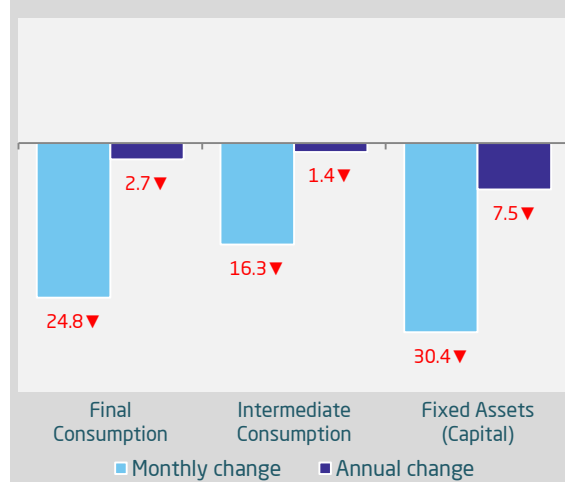
Imports by Utilization of Items

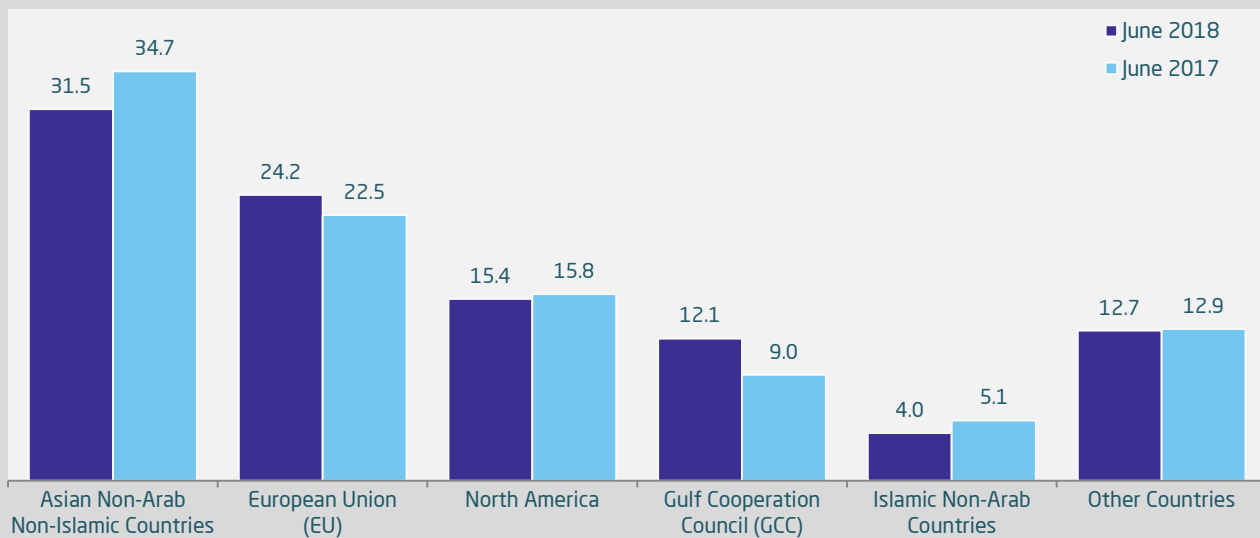

Change in Imports by Group of Countries, June 2018 (%)

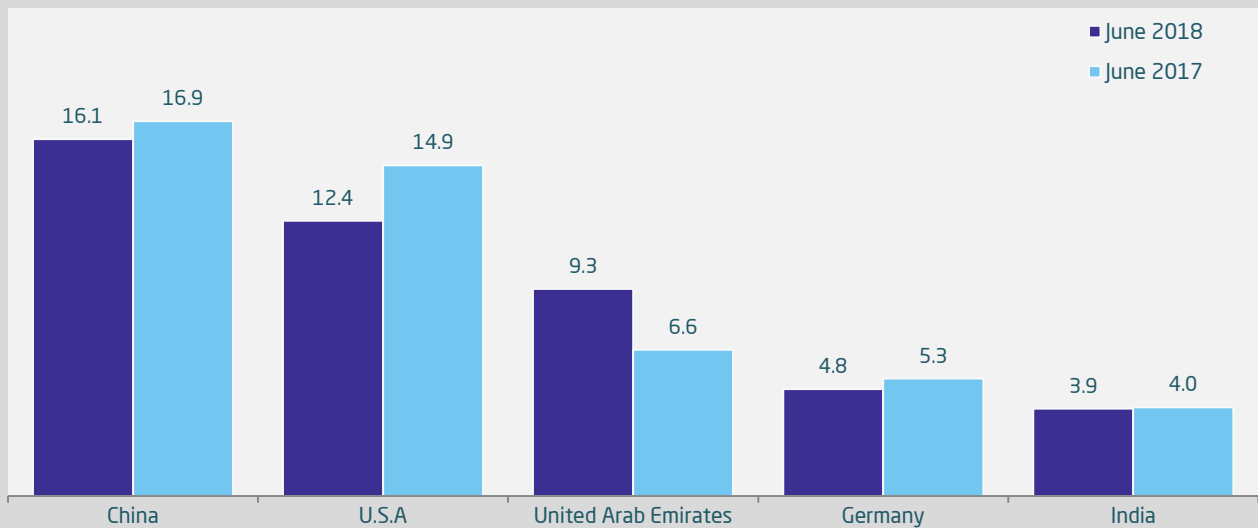




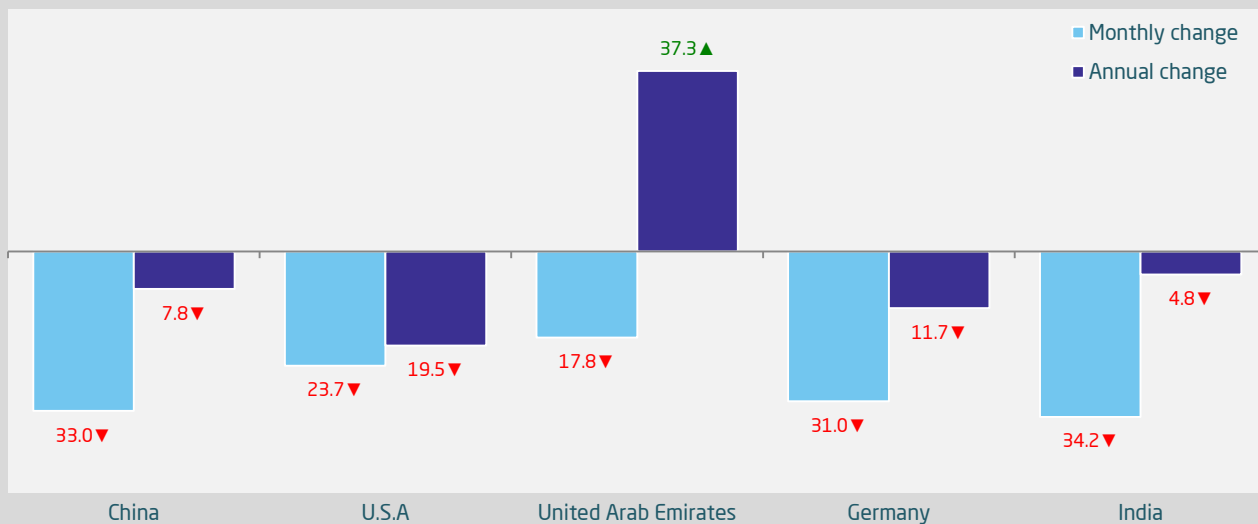

3. Trade Volume and Trade Balance

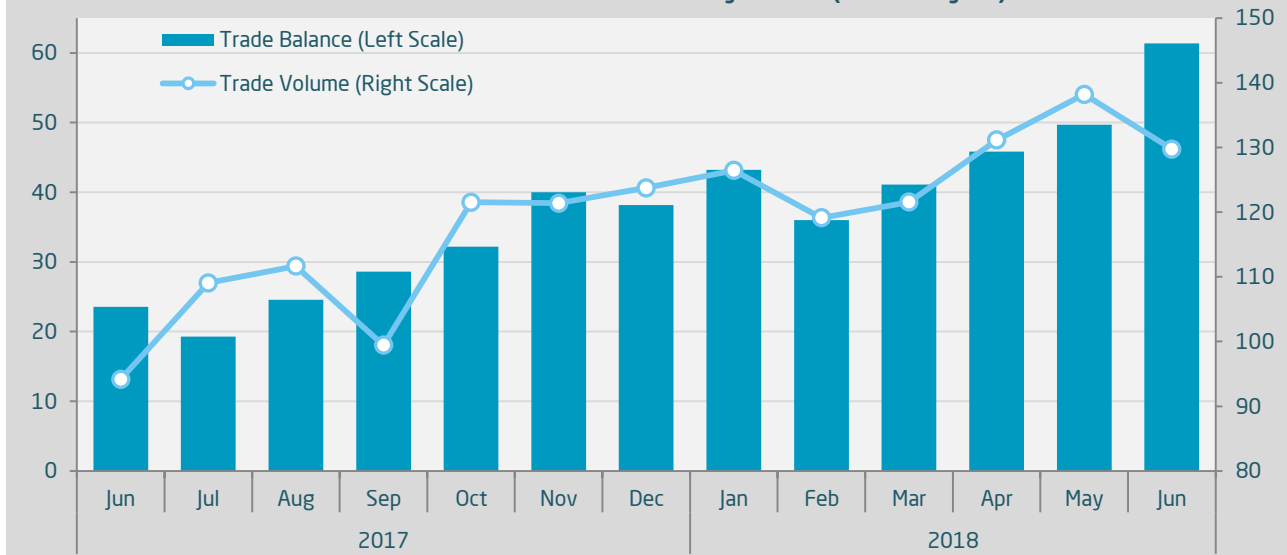
Merchandise trade volume amounted to 129749 million riyals in June 2018 compared to 94175 million riyals in June 2017, corresponding to an increase of 35574 million riyals or 37.8%. The trade balance yielded a surplus of 61339 million riyals in June 2018, which was higher than the surplus of 23530 million riyals recorded in the same month of the previous year by 37809 million riyals or 160.7%.

Trade Balance and Trade Volume by Month (Billion Riyals)





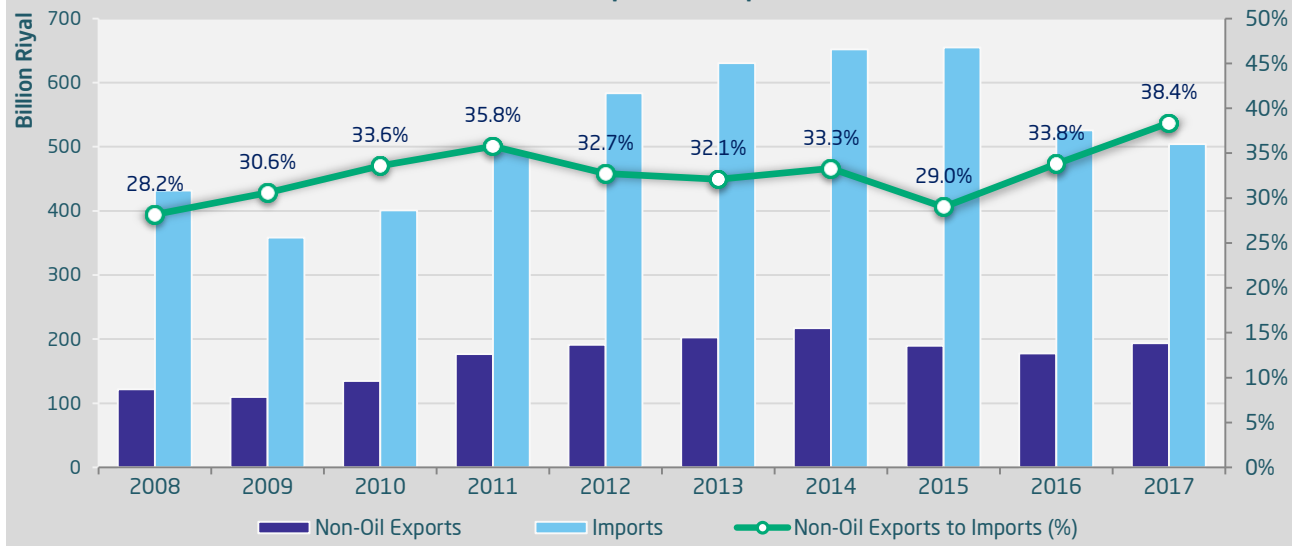
4. Ratio of Non-oil Exports to Imports, Monthly

Non-oil exports and imports amounted to 16777 million riyals and 34205 million riyals, respectively, in June 2018 compared to 13246 million riyals and 35322 million riyals, respectively, in June 2017. Accordingly, the ratio of non-oil exports to imports increased to 49.0% in June 2018 from 37.5% in the same period last year as a result of an increase in non-oil exports (26.7%) in contrast to a decline in imports (3.2%) over that period.

Ratio of Non-oil Exports to Imports, Annual

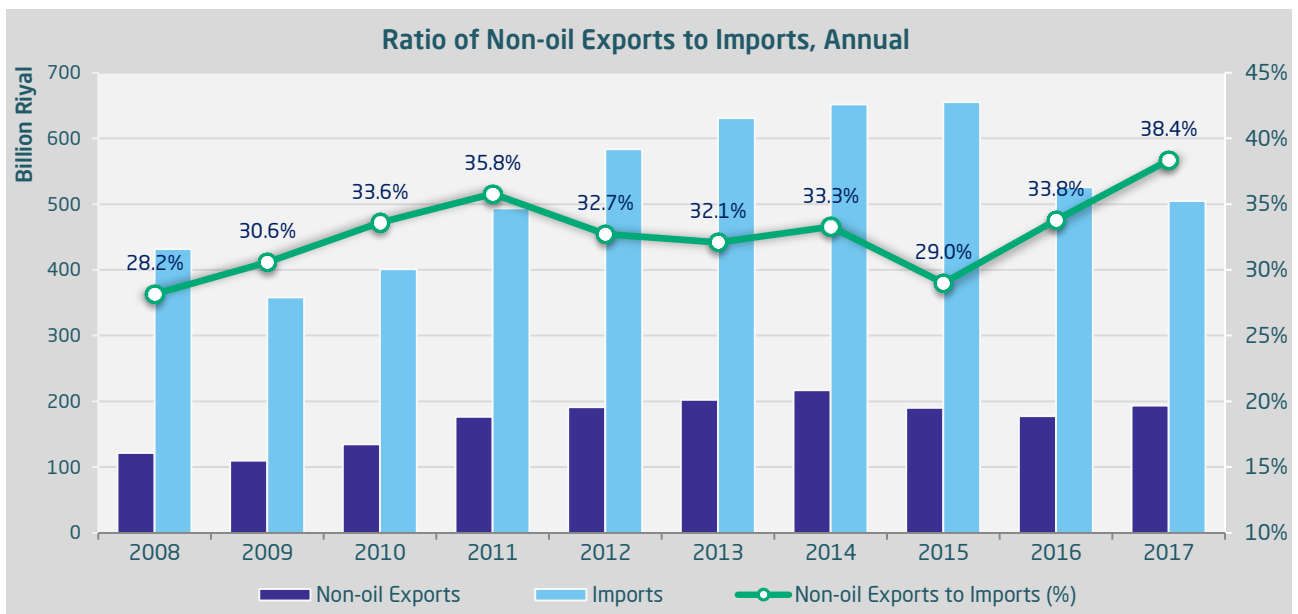




5. Ratio of Non-oil Exports to Imports, Annual

Non-oil exports and imports amounted to 193479 million riyals and 504447 million riyals, respectively, in 2017 compared to 177694 million riyals and 525636 million riyals, respectively, in 2016. Accordingly, the ratio of non-oil exports to imports increased to 38.4% in 2017 from 33.8% in 2016 as a result of an increase in non-oil exports (8.9%) in contrast to a decline in imports (4.0%) over that period.

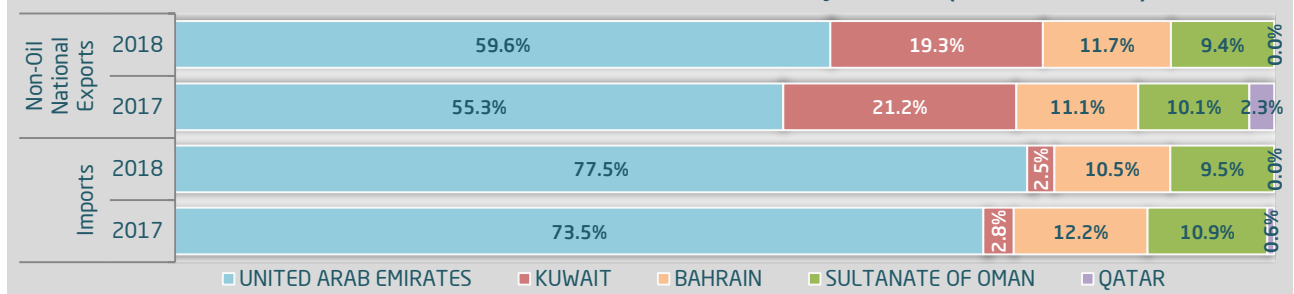
6. Trade between Saudi Arabia and GCC Countries

In June 2018, non-oil exports of Saudi Arabia of national origin to the GCC countries amounted to 2286 million riyals compared to 2054 million riyals in the same period of the previous year, with an increase of 232 million riyals or 11.3%. Saudi Arabia's imports of goods from the GCC countries amounted to 4124 million riyals in June 2018 compared to 3166 million riyals in the same period of the previous year, with an increase of 958 million riyals or 30.3%.

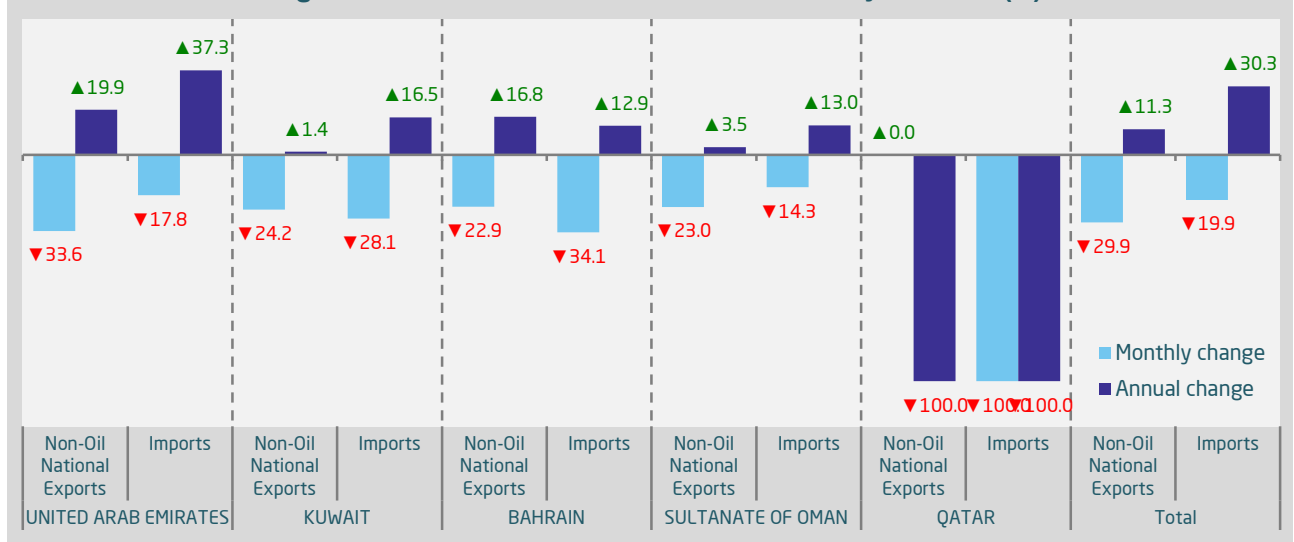
