

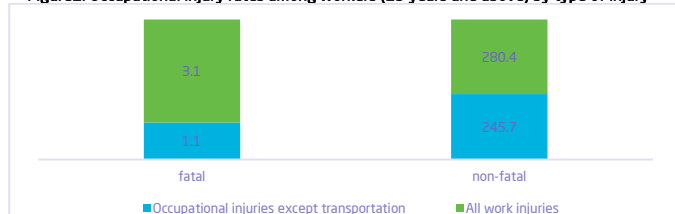
40.4% of workers have dedicated occupational health and safety department at their workplace

According to administrative records, the rate of non-fatal occupational injuries was 245.7, while the rate of fatal occupational injuries was 1.1 per 100 thousand workers among workers aged 15 years and above, excluding road traffic accidents. Regarding the workplace, 39% of workers received training on occupational health and safety (OHS) procedures. Furthermore, 40.4% had a dedicated OHS department at their workplace, 38.8% had an OHS representative, and 32.2% underwent periodic medical examinations provided by the employer. Concerning risks in the work environment, the results showed that 5.4% of workers operated hazardous machinery, 2.1% handled chemical substances, and 1% were exposed to heavy metals.

In the healthcare sector, 95% of workers had coverage for basic health care. The most common work-related health issues during the past 12 months were work-related stress with 2.1%, followed by eye and vision problems with 2%, while 79.5% of workers reported no work-related health problems during the same period.

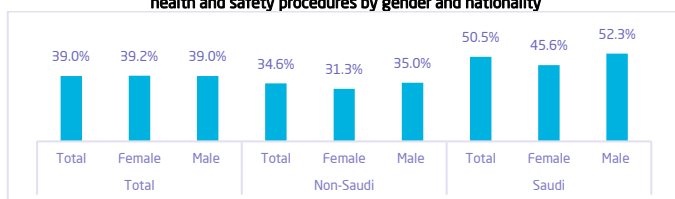
Rate of occupational injuries among workers (15 years and above) reaches 245.7 non-fatal injuries and 1.1 fatal injuries per 100 thousand workers

Figure1: Occupational injury rates among workers (15 years and above) by type of injury



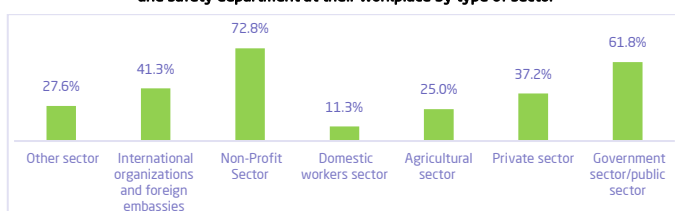

Figure2: Percentage of workers (18 years and above) who receive training on occupational health and safety procedures by gender and nationality



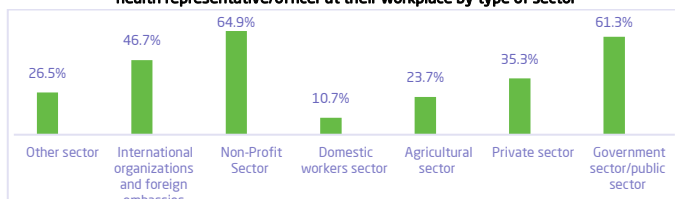

Figure3: Percentage of workers (18 years and above) who have a dedicated occupational health and safety department at their workplace by type of sector



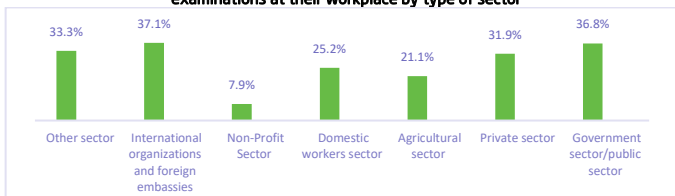
38.8% of workers have occupational health and safety representative at their workplace

Figure4: Percentage of workers (18 years and above) who have an occupational safety and health representative/officer at their workplace by type of sector



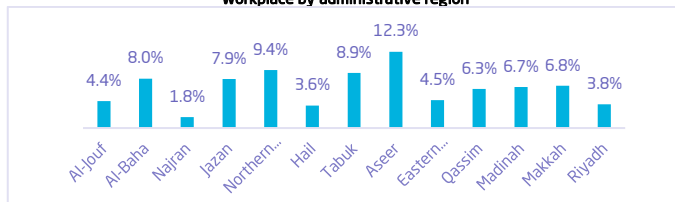
32.2% of workers undergo periodic medical examinations at their workplace

Figure5: Percentage of workers (18 years and above) who undergo periodic medical examinations at their workplace by type of sector



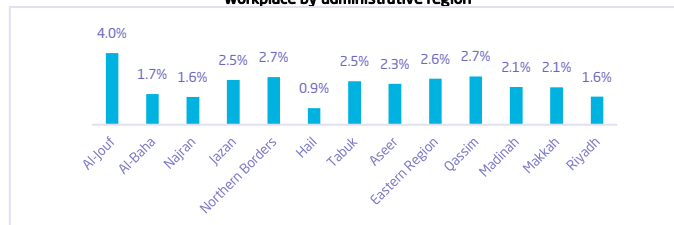
5.4% of workers operate hazardous machinery in their workplace

Figure6: Percentage workers (18 years and above) who operate hazardous machinery in their workplace by administrative region



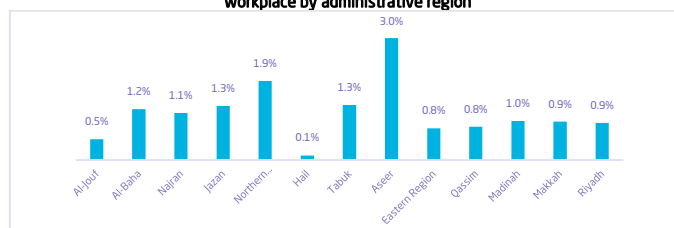
2.1% of workers handle chemical substances that may cause allergies, irritation, or other diseases

Figure7: Percentage of workers (18 years and above) who handle chemical substances in their workplace by administrative region



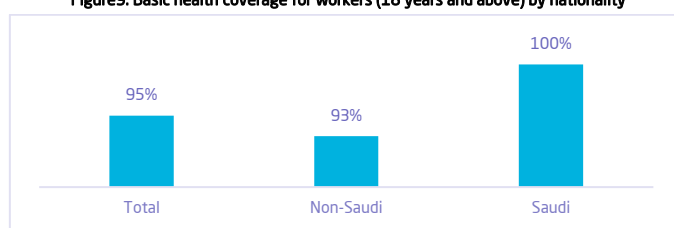

Figure8: Percentage of workers (18 years and above) who are exposed to heavy metals in their workplace by administrative region



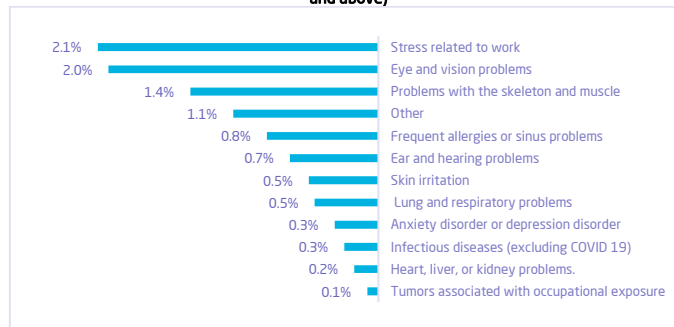

Estimates of health and safety at workplace statistics are based on self-reported data from participants via household field visits conducted in the National Health Survey 2024 (NHS), except for the work-related injuries rate, which was calculated from register-based data from the National Council for Occupational Safety and Health.

This publication reviews statistical indicators for occupational health and safety (OHS) among workers (aged 18 years and above). The indicators are based on the results of the National Health Survey 2024, population estimates from the General Authority for Statistics (GASTAT) for the year 2024, and administrative data from the National Council for Occupational Safety and Health.
