Introduction

This report presents the developments in merchandise exports and imports of the Kingdom of Saudi Arabia for the year 2016 as compared to the previous year according to the statistical methods and international standard classifications, mainly the Harmonized System (H.S).

It should be noted that the statistics presented in this report are preliminary and they may undergo some modifications in case of a data update.

Note: There might be some differences in the aggregates of numbers or percentages due to rounding.




1. Merchandise Exports

1.1. Developments in Exports



Total merchandise exports of the Kingdom of Saudi Arabia amounted to 688.4 billion riyals in 2016 with an annual decrease of 74.9 billion riyals or 9.8% as compared to 763.3 billion riyals in 2015.





1.2. Oil Exports



Oil exports of Saudi Arabia amounted to 510.7 billion riyals in 2016 as compared to 573.4 billion riyals in 2015, with a decrease of 62.7 billion riyals or 10.9%. Its share in the total merchandise exports also decreased from 75.1% in 2015 to 74.2% in 2016.





1.3. Non-Oil Exports

Non-oil merchandise exports reached 177.7 billion riyals in 2016 as compared to 189.9 billion riyals in 2015, with a decrease of 12.2 billion riyals or 6.4%. Its share in the total merchandise exports increased from 24.9% in 2015 to 25.8% in 2016 in parallel with a relatively sharper decline in oil exports over that period.








Main Export Products (Share in total exports, %)




Annual Change in Main Export Products, 2016 (%)






Exports by Nature of Items







Annual Change in Exports to the Top 10 Countries, 2016 (%)







Imports by Nature of Items







Annual Change in 2016 (%)









3. Trade Balance and Trade Volume


Merchandise exports and imports of Saudi Arabia amounted to 688.4 billion riyals and 525.6 billion riyals, respectively, leading to a trade surplus of 162.8 billion riyals in 2016, up 54.5 billion riyals or 50.3% as compared to the surplus of 108.3 billion riyals in 2015.

The volume of merchandise trade (exports plus imports) amounted to 1214 billion riyals in 2016 compared to 1418 billion in 2015, down 204 billion riyals or 14.4%.

Exports, Imports, Trade Balance, and Trade Volume






4. Ratio of Non-oil Exports to Imports

In 2016, non-oil exports amounted to 177.7 million riyals and accounted for 33.8% of the imports. The previous year, non-oil exports amounted to 189.9 million riyals and accounted for 29.0% of the imports.

Ratio of Non-oil Exports to Imports, Annual







5. Trade between Saudi Arabia and GCC Countries

The Kingdom's exports of domestic goods to the GCC countries added up to 64223 million ryals in 2016 with an annual increase of 2043 million ryals or 3.3% as compared to 62180 million ryals in 2015. The Kingdom's imports of goods originated from the GCC countries amounted to 41033 million ryals in 2016 as compared to 48714 million ryals in 2015, down 7681 million ryals or 15.8%.
