## Introduction

This report presents the developments in commodity exports and imports of the Kingdom of Saudi Arabia for the Second Quarter of 2017 as compared to the same period of the previous year, 2016, according to the statistical methods and international standard classifications, mainly the Harmonized System (H.S).

It should be noted that the statistics presented in this report are preliminary and they may undergo some modifications in case of a data update.

**Note:** There might be some differences in the aggregates of numbers or percentages due to rounding.



## 1. Merchandise Exports

Total merchandise exports of Saudi Arabia amounted to 189064 million riyals in the Second Quarter (Q2) of 2017 as compared to 175941 million riyals in the corresponding period of the previous year, up by 13123 million riyals or 7.5%.

In addition, exports in 2017 Q2 were lower than those in the preceding quarter (2017 Q1) by 17657 million riyals or 8.5%.




## 1-1 Oil Exports

Oil exports of Saudi Arabia amounted to 144371 million riyals in the Second Quarter (Q2) of 2017 as compared to 130310 million riyals in the corresponding period of the previous year, up by 14061 million riyals or 10.8%.

However, oil exports in 2017 Q2 were lower than those in the preceding quarter (2017 Q1) by 17501 million riyals or 10.8%.



## 1-2 Non-oil Merchandise Exports

### 1.2.1. Developments in Non-Oil Exports

Non-oil exports of Saudi Arabia amounted to 44693 million riyals in the Second Quarter (Q2) of 2017 as compared to 45631 million riyals in the corresponding period of the previous year, down by 938 million riyals or 2.1%. Also, non-oil exports in 2017 Q2 were lower than those in the preceding quarter (2017 Q1) by 156 million riyals or 0.3%.





## 2. Merchandise Imports

### 2.1. Developments in Imports

Total imports of Saudi Arabia amounted to 125948 million riyals in the Second Quarter (Q2) of 2017 as compared to 139626 million riyals in the corresponding period of the previous year, down by 13678 million riyals or 9.8%.

However, Imports in 2017 Q2 were higher than those in the preceding quarter (2017 Q1) by 389 million riyals or 0.3%.





Change in Imports to Top 5 Countries, Q2 2017 (%)






### 3. Ratio of Non-oil Exports to Imports, Quarterly

In the Second Quarter of 2017, non-oil exports amounted to 44693 million riyals and accounted for 35.5% of the imports. In the same period of the previous year, non-oil exports amounted to 45631 million riyals and accounted for 32.7% of the imports.






## 4. Ratio of Non-oil Exports to Imports, Annual

In 2016, non-oil exports amounted to 177694 million riyals and accounted for 33.8% of the imports. The previous year, non-oil exports amounted to 189901 million riyals and accounted for 29% of the imports.


## 5. Trade between Saudi Arabia and GCC Countries

In the Second Quarter of 2017, non-oil exports of Saudi Arabia of national origin to GCC countries reached 8030 million riyals as compared to 8463 million riyals in the same period of the previous year, with a decrease of 433 million riyals corresponding to 0.1%. Saudi Arabia's imports of goods originated from GCC countries amounted to 11386 million riyals as compared to 11021 million riyals in the same period of the previous year, with an increase of 366 million riyals corresponding to 0.03%.


