Introduction

This report presents the developments in merchandise exports and imports of the Kingdom of Saudi Arabia for the year 2018 as compared to the previous year, 2017, according to the statistical methods and various classifications. The data for this report were collected from the Saudi Customs and the Ministry of Energy, Industry, and Mineral Resources.

All the data contained in this report and more details are attached to this report in an Excel file, which could be downloaded from the website of the General Authority for Statistics. (GaStat)

Note: There might be some differences in the aggregates of numbers or percentages due to rounding.

Description

This report presents the statistics on exports and imports of the Kingdom of Saudi Arabia for the latest year with available data in comparison with the same period from last year. It highlights the main developments with summary tables and charts. Given the importance of oil exports to the Saudi economy, total exports are separated into oil exports and non-oil exports. Non-oil exports and imports are then presented in various classifications such as by section (HS), by group of countries, by partner countries, by means of transport and customs port. Appendix tables are also given at the end of the report and in a separate Excel file that could be downloaded from the GaStat website.

Data Collection, Processing, and Dissemination

The General Authority for Statistics receives the monthly data from two sources; (i) Saudi Customs and (ii) Ministry of Energy, Industry, and Mineral Resources.

The data pass through several stages of treatment before dissemination, as explained below.

First Stage:

Entering the data on the system of foreign trade statistics to obtain a preliminary review of commodities, countries, and customs centers to ensure consistency and comprehensiveness of the data.



Second Stage:

The implementation of processing programs for detailed customs data, through the application of auditing rules and automatic correction to extract notes. These notes are either processed directly by expert statisticians in the Department of Foreign Trade Statistics or investigated from its official source. This stage continues until the monthly data is completely audited and corrected.

Third Stage:

Aggregation of monthly data by commodity and country automatically by means of programs dedicated to this purpose. After that, a final and comprehensive review is conducted and thus the data become ready to be published.

Fourth Stage:

Various tables for different classifications are extracted from the system to prepare the reports, which are published on a regular basis on the GaStat website.

Classification Used

The basic data on the foreign trade included in this report is based on the Harmonized Commodity Description and Coding Systems, known as the Harmonized System (HS).

Concepts and Definitions

Exports (Total):

Exports consist of exports of domestic goods (national exports) and exports of foreign goods (re-exports). Valuation is on Free-on-Board (FOB) basis.

National Exports:

Exports of all goods fully produced or manufactured in the country or undergone some modifications that lead to a change in their shapes and values.

Re-exports:

Refers to the sale of previously imported goods abroad without any clear modifications on them.

Oil Exports:

Exports of goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS).

Non-oil Exports:

Total exports minus exports of goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS).

Imports:

Refer to all goods entering the country after passing through the customs procedures to meet its local needs. Valuation is on Cost, Insurance, and Freight (CIF) basis.

Trade Volume:

The sum of exports and imports.

Trade Balance:

Total exports minus imports.

Non-oil Trade Balance:

Non-oil exports minus imports.


Annual change:

Change from the previous year.

1. Merchandise Exports


Total merchandise exports of Saudi Arabia amounted to 1 trillion 103 billion 900 million riyals in 2018 compared to 831 billion 881 million riyals in 2017, corresponding to an increase of 272 billion 19 million riyals or 32.7% over the previous year.






1.1. Oil Exports

Oil exports valued at 868 billion 442 million riyals in 2018 compared to 638 billion 402 million riyals in 2017, with an increase of 230 billion 40 million riyals or 36.0% over the previous year. The share of oil exports in total merchandise exports also increased from 76.7% in 2017 to 78.7% in 2018.







1.2. Non-oil Merchandise Exports

1.2.1. Developments in Non-oil Exports


Non-oil exports amounted to 235 billion 458 million riyals in 2018 compared to 193 billion 479 million riyals in 2017, corresponding to an increase of 41 billion 979 million riyals or 21.7% over the previous year. The share of non-oil exports in total merchandise exports, however, decreased from 23.3% in 2017 to 21.3% in 2018.












1.2.6. Re-exports

Products re-exported by Saudi Arabia amounted to 31 billion 688 million riyals in 2018 compared to 32 billion 346 million riyals in 2017, down by 657 million riyals or 2.0% over the previous year.

United Arab Emirates was the main destination for the re-exports, accounting for 39.5% of the total re-exports of the Kingdom in 2018, followed by U.S.A with a share of 7.5%.





2.1. Developments in Imports



2.3. Imports by Nature and Utilization of Items





3. Trade Volume and Trade Balance

Merchandise trade volume of Saudi Arabia amounted to 1 trillion 617 billion 893 million riyals in 2018 compared to 1 trillion 336 billion 328 million riyals in 2017, corresponding to an increase of 281 billion 565 million riyals or 21.1% over the previous year. On the other hand, the Kingdom recorded a surplus of 589 billion 908 million riyals in its merchandise trade in 2018, up by 262 billion 473 million riyals from the surplus of 327 billion 435 million riyals registered in the previous year.



4. Ratio of Non-oil Exports to Imports

Non-oil exports increased from 193 billion 479 million riyals in 2017 to 235 billion 458 million riyals in 2018 while imports increased from 504 billion 447 million riyals to 513 billion 993 million riyals over the same period. Accordingly, the ratio of non-oil exports to imports increased to 45.8% in 2018 from 38.4% in the previous year as a result of a higher increase in non-oil exports (21.7%) than in imports (1.9%) over the previous year.

5. Trade between Saudi Arabia and GCC Countries

Non-oil exports of Saudi Arabia of national origin to the GCC countries amounted to 32 billion 634 million riyals in 2018 compared to 32 billion 433 million riyals in 2017, corresponding to an increase of 202 million riyals or 0.6% over the previous year. Saudi Arabia's imports of goods from the GCC countries amounted to 56 billion 924 million riyals in 2018 compared to 45 billion 379 million riyals in 2017, with an increase of 11 billion 545 million riyals or 25.4% over the previous year.


