# Non-oil exports increase by 15.6% while oil exports fall in January 2021

Overall merchandise exports decreased by 13.4% in January 2021 compared to January 2020. The value of exports amounted to 71.9 billion riyals in January 2021, down from 83.0 billion riyals in January 2020. This decrease originated mainly from oil exports, which fell by 13.7 billion riyals or 20.5% in the same period. The share of oil exports in total exports, therefore, decreased from 80.3% (January 2020) to 73.7% (January 2021). However, compared to the previous month (December 2020), total merchandise exports increased by 7.1 billion riyals or 11.0%.

Non-oil exports increased by 15.6% year-on-year in January 2021, rising to 18.9 billion riyals from 16.3 billion riyals (January 2020). Of the most important non-oil goods, 'Plastics and Rubber and Articles Thereof' (32.4% of non-oil merchandise exports) increased by 24.5% (1.2 billion riyals) and 'Products of the Chemical or Allied Industries' (27.5% of non-oil merchandise exports) increased by 3.3% (0.2 billion riyals) from January 2020. Non-oil exports increased compared to the previous month (December 2020) by 0.5 billion riyals or 2.6%.

Merchandise imports increased by 20.7% (8.2 billion riyals) year-on-year in January 2021. The value of imports amounted to 47.9 billion riyals in January 2021 compared to 39.7 billion riyals in January 2020. This increase was due to the increase in many sectors compared to January 2020, mainly 'Arms and Ammunition; Parts and Accessories Thereof' (524.9%) and 'Base Metals and Articles of Base Metal' (17.9%). Imports also increased compared to the previous month (December 2020), by 3.0 billion riyals or 6.8%.

#### Ratio of Non-oil Exports to Imports decreased to 39.4%

The ratio of non-oil exports to imports decreased to 39.4% in January 2021 from 41.1% in January 2020, as a result of a higher increase in imports (20.7%) than in non-oil exports (15.6%) over that period.

#### China is Saudi Arabia's main trading partner for merchandise trade

In January 2021, exports to China amounted to 14.0 billion riyals, making this country the main destination for exports of Saudi Arabia. India and Japan followed next with 7.8 billion riyals and 7.6 billion riyals, respectively. South Korea, United Arab Emirates, U.S.A, Egypt, Bahrain, Singapore, and Belgium were the other countries that ranked in the top 10 destinations. Exports of Saudi Arabia to those 10 countries amounted to 50.2 billion riyals, accounting for 69.8% of the total exports.

Imports from China amounted to 9.6 billion riyals in January 2021, making this country the main origin for imports of Saudi Arabia. U.S.A and United Arab Emirates followed next with imports of 8.0 billion riyals and 3.7 billion riyals, respectively. India, Germany, Japan, France, United Kingdom, Italy and South Korea were the other countries that ranked in the top 10 countries for imports. Imports of Saudi Arabia from those 10 countries amounted to 33.6 billion riyals, accounting for 70.1% of the total imports.

### **Top Five Customs Ports for Imports**

16.2 billion riyals of imports, corresponding to 33.7% of the total, entered the Kingdom from Jeddah Islamic Sea Port in January 2021. Among the other major ports of entry for the imports were King Abdulaziz Port (16.5%), King Khalid International Airport (11.9%), Bat'ha (6.6%), and Riyadh (Dry Port) (6.2%). Those five ports together accounted for 74.9% of the total merchandise imports of the Kingdom.

## Methodology

GASTAT's statistics on International trade are built on administrative records from Saudi Customs (non-oil) and the Ministry of Energy (oil). Saudi Arabia's merchandise exports and imports are classified according to the Harmonized Commodity Description and Coding Systems (2017), also known as the Harmonized System (HS), which is maintained by the World Customs Organization (WCO). The HS allows countries to classify traded products in an internationally standardized system of product names and codes. Oil exports refer to exported goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS). Non-oil exports refer to all other goods exported (including petrochemicals).
