

# Non-oil and oil exports increase by 70.0% and 146.7% in May 2021

Overall merchandise exports increased by 120.1% in May 2021 compared to May 2020, when international trade was impacted by Covid-related lockdowns and travel bans in numerous countries. The value of exports amounted to 82.2 billion riyals in May 2021, up from 37.3 billion riyals in May 2020. This increase originated mainly from oil exports, which rose by 35.8 billion riyals or 146.7% in the same period. The share of oil exports in total exports increased from 65.3% (May 2020) to 73.2% (May 2021). Compared to the previous month (April 2021), total merchandise exports increased by 10.5 billion riyals or 146.6%.

Non-oil exports increased by 70.0% year-on-year in May 2021, rising to 22.0 billion riyals from 12.9 billion riyals in May 2020. Of the most important non-oil goods, 'Plastics and Rubber and Articles Thereof' (35.4% of non-oil merchandise exports) increased by 82.9% 3.5 billion riyals) and 'Products of the Chemical or Allied Industries' (31.7% of non-oil merchandise exports) increased by 86.4% 3.2 billion riyals) from May 2020. Non-oil exports increased compared to the previous month (April 2021) by 2.0 billion riyals or 10.0%.

Merchandise imports increased by 20.3% (7.5 billion riyals) in May 2021. The value of imports amounted to 44.4 billion riyals in May 2021 compared to 36.9 billion riyals in May 2020. This increase was due to the increase in many sectors compared to May 2020, mainly 'Vehicles and Associated Transport Equipment' (36.4%) and 'Mineral Products' (139.3%). Imports, however, decreased compared to the previous month (April 2021), by -5.4 billion riyals or 10.8%.

## Ratio of Non-oil Exports to Imports increased to 49.6%

The ratio of non-oil exports to imports increased to 49.6% in May 2021 from 35.1% in May 2020, as a result of a higher increase in non-oil exports (70.0%) than in imports (20.3%) over that period.

## China is Saudi Arabia's main trading partner for merchandise trade

In May 2021, exports to China amounted to 17.6 billion riyals (21.4% of total exports), making this country the main destination for exports of Saudi Arabia. India and Japan followed next with 7.6 billion riyals (9.3% of total exports) and 6.1 billion riyals (7.5% of total exports), respectively. South Korea, U.S.A, United Arab Emirates, the Netherlands, Singapore, Taiwan, and Egypt were the other countries that ranked in the top 10 destinations. Exports of Saudi Arabia to those 10 countries amounted to 55.9 billion riyals, accounting for 68.0% of total exports.

Imports from China amounted to 8.1 billion riyals in May 2021 (18.2% of total imports), making this country the main origin for imports of Saudi Arabia. U.S.A and United Arab Emirates followed next with imports of 4.6 billion riyals (10.3% of total imports) and 4.1 billion riyals (9.3% of total imports), respectively. Germany, India, Japan, Egypt, Italy, United Kingdom and France were the other countries that ranked in the top 10 countries for imports. Imports of Saudi Arabia from those 10 countries amounted to 28.4 billion riyals, accounting for 63.8% of total imports.

#### **Top Five Customs Ports for Imports**

11.7 billion riyals of imports, corresponding to 26.4% of the total, entered the Kingdom from Jeddah Islamic Sea Port in May 2021. Among the other major ports of entry for the imports were King Abdulaziz Port (18.9%), King Khalid International Airport (11.0%), King Fahad Airport (6.8%), and Bat'ha (5.9%). Those five ports together accounted for 69.1% of the total merchandise imports of the Kingdom.

# Methodology

GASTAT's statistics on International trade are built on administrative records from Saudi Customs (non-oil) and the Ministry of Energy (oil). Saudi Arabia's merchandise exports and imports are classified according to the Harmonized Commodity Description and Coding Systems (2017), also known as the Harmonized System (HS), which is maintained by the World Customs Organization (WCO). The HS allows countries to classify traded products in an internationally standardized system of product names and codes. Oil exports refer to exported goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS). Non-oil exports refer to all other goods exported (including petrochemicals).


