Introduction

This report presents the developments in merchandise exports and imports of the Kingdom of Saudi Arabia for March 2019 as compared to the same period of the previous year, March 2018, according to the statistical methods and various classifications. The data for this report were collected from the Saudi Customs and the Ministry of Energy, Industry, and Mineral Resources.

All the data contained in this report and more details are attached to this report in an Excel file, which could be downloaded from the website of the General Authority for Statistics. (GaStat)

It should be noted that the statistics presented in this report are preliminary and they may undergo some modifications in case of a data update.

Note: There might be some differences in the aggregates of numbers or percentages due to rounding.

Methodology

Description

This report presents the statistics on exports and imports of the Kingdom of Saudi Arabia for the latest month with available data in comparison with the same period from last year. It highlights the main developments with summary tables and charts. Given the importance of oil exports to the Saudi economy, total exports are separated into oil exports and non-oil exports. Non-oil exports and imports are then presented in various classifications such as by section (HS), by group of countries, by partner countries, by means of transport and customs port. Appendix tables are also given at the end of the report and in a separate Excel file that could be downloaded from the GaStat website.

Data Collection, Processing, and Dissemination

The General Authority for Statistics receives the monthly data from two sources; (i) Saudi Customs and (ii) Ministry of Energy, Industry, and Mineral Resources.

The data pass through several stages of treatment before dissemination, as explained below.

First Stage:

Entering the data on the system of foreign trade statistics to obtain a preliminary review of commodities, countries, and customs centers to ensure consistency and comprehensiveness of the data.

Second Stage:

The implementation of processing programs for detailed customs data, through the application of auditing rules and automatic correction to extract notes. These notes are either processed directly by expert statisticians in the Department of Foreign Trade Statistics or investigated from its official source. This stage continues until the monthly data is completely audited and corrected.

Third Stage:

Aggregation of monthly data by commodity and country automatically by means of programs dedicated to this purpose. After that, a final and comprehensive review is conducted and thus the data become ready to be published.

Fourth Stage:

Various tables for different classifications are extracted from the system to prepare the monthly report. The report is published on a regular basis every month on the GaStat website.

Classification Used

The basic data on the foreign trade included in this report is based on the Harmonized Commodity Description and Coding Systems, known as the Harmonized System (HS).



Concepts and Definitions

Exports (Total):

Exports consist of exports of domestic goods (national exports) and exports of foreign goods (re-exports). Valuation is on Free-on-Board (FOB) basis.

National Exports:

Exports of all goods fully produced or manufactured in the country or undergone some modifications that lead to a change in their shapes and values.

Re-exports:

Refers to the sale of previously imported goods abroad without any clear modifications on them.

Oil Exports:

Exports of goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS).

Non-oil Exports:

Total exports minus exports of goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS).

Imports:

Refer to all goods entering the country after passing through the customs procedures to meet its local needs. Valuation is on Cost, Insurance, and Freight (CIF) basis.

Trade Volume:

The sum of exports and imports.

Trade Balance:

Total exports minus imports.

Non-oil Trade Balance:

Non-oil exports minus imports.

Monthly change:

Change from the previous month.

Annual change:

Change from the same month of the previous year.

1. Merchandise Exports

Total merchandise exports of Saudi Arabia amounted to 85 billion 821 million riyals in March 2019 compared to 82 billion 447 million riyals in March 2018, corresponding to an increase of 3 billion 374 million rivals or 4.1% over that period. Merchandise exports in March 2019 were also higher than those in the preceding month (February 2019) by 8 billion 767 million rivals or 11.4%.







1.1. Oil Exports

Oil exports of Saudi Arabia valued at 66 billion 148 million riyals in March 2019 compared to 62 billion 188 million riyals in March 2018, corresponding to an increase of 3 billion 960 million riyals or 6.4% over that period. The share of oil exports in total merchandise exports also increased from 75.4% in March 2018 to 77.1% in March 2019.

Compared to the previous month (February 2019), the value of oil exports increased by 6 billion 781 million rivals or 11.4% in March 2019.








1.2. Non-oil Merchandise Exports


1.2.1. Developments in Non-oil Exports

Non-oil exports of Saudi Arabia amounted to 19 billion 673 million riyals in March 2019 compared to 20 billion 259 million riyals in March 2018, corresponding to a decrease of 586 million riyals or 2.9% over that period. The share of non-oil exports in total merchandise exports also decreased from 24.6% in March 2018 to 22.9% in March 2019.

Compared to the previous month (February 2019), the value of non-oil exports increased by 1 billion 986 million riyals or 11.2% in March 2019.






1.2.6. Re-exports

Products re-exported by Saudi Arabia amounted to 3 billion 184 million rivals in March 2019 compared to 2 billion 924 million riyals in March 2018, up by 260 million riyals or 8.9% over that period.

United Arab Emirates was the main destination for the re-exports, accounting for 31.8% of the total re-exports of the Kingdom in March 2019, followed by Bahrain with a share of 17.5%.







2. Merchandise Imports


2.1. Developments in Imports

Total merchandise imports of Saudi Arabia amounted to 41 billion 110 million riyals in March 2019 compared to 41 billion 806 million riyals in March 2018, corresponding to a decrease of 696 million riyals or 1.7% over that period.

Merchandise imports in March 2019 were, however, higher than those in the preceding month (February 2019) by 5 billion 803 million rivals or 16.4%.











3. Trade Volume and Trade Balance

Merchandise trade volume of Saudi Arabia amounted to 126 billion 931 million riyals in March 2019 compared to 124 billion 253 million rivals in March 2018, corresponding to an increase of 2 billion 678 million rivals or 2.2%. On the other hand, the Kingdom recorded a surplus of 44 billion 711 million riyals in its merchandise trade in March 2019, up by 4 billion 70 million riyals from the surplus of 40 billion 641 million riyals registered in March 2018.

4. Ratio of Non-oil Exports to Imports, Monthly

Non-oil exports decreased from 20 billion 259 million riyals in March 2018 to 19 billion 673 million riyals in March 2019 while imports decreased from 41 billion 806 million riyals to 41 billion 110 million rivals over the same period. Accordingly, the ratio of non-oil exports to imports decreased to 47.9% in March 2019 from 48.5% in March 2018 as a result of a larger decrease in non-oil exports (2.9%) than in imports (1.7%) over that period.




5. Ratio of Non-oil Exports to Imports, Annual

Non-oil exports increased from 193 billion 479 million riyals in 2017 to 235 billion 458 million riyals in 2018 while imports increased from 504 billion 447 million riyals to 513 billion 993 million riyals over the same period. Accordingly, the ratio of non-oil exports to imports increased to 45.8% in 2018 from 38.4% in the previous year as a result of a higher increase in non-oil exports (21.7%) than in imports (1.9%) over the previous year.





6. Trade between Saudi Arabia and GCC Countries

Non-oil exports of Saudi Arabia of national origin to the GCC countries amounted to 2 billion 599 million riyals in March 2019 compared to 3 billion 37 million riyals in March 2018, with a decrease of 438 million riyals or 14.4% over that period. Saudi Arabia's imports of goods from the GCC countries amounted to 4 billion 818 million riyals in March 2019 compared to 4 billion 867 million riyals in March 2018, down by 49 million rivals or 1.0% over that period.
